

1 THE WITNESS: Service Center. I think that's the
2 appropriate title for her, and she was certainly leading the
3 meeting that day.

4 ADMINISTRATIVE LAW JUDGE BLUBAUGH: And what group
5 is this Capital Service Center? Do you know?

6 THE WITNESS: Well, that's sort of murky, actually,
7 because there are people who attend from local, from CTA and
8 NEA. And certainly that particular evening you had, Lois
9 Tenson (phonetic) was there, the President of CTA. You had
10 Bob Chase there. So I don't know who all is officially
11 invited. I think they'll have to speak to that. But you had
12 individual members like myself there, too.

13 ADMINISTRATIVE LAW JUDGE BLUBAUGH: Okay. Did Chase
14 ever say anything?

15 THE WITNESS: Oh, yes, he did. He turned around and
16 he, he said that's not true, that's not true. I don't make
17 270 or 80 thousand. And of course, some people at my table
18 chuckled and said yeah, he makes more, but that's what he
19 said.

20 And then, of course, afterwards he said plenty
21 because I went up to him.

22 ADMINISTRATIVE LAW JUDGE BLUBAUGH: Okay, let's let
23 your counsel take you there.

24 BY MR. CARLISLE:

25 Q Okay. Afterwards, as Patty will testify, she
26 offered to introduce you to Mr. Chase, is that correct?

27 A Yes, she asked me if I would like to --

28 MS. FEINBERG: Objection. I mean he's leading and

1 he's offering evidence that is not in the record as of yet.

2 MR. CARLISLE: Okay.

3 ADMINISTRATIVE LAW JUDGE BLUBAUGH: Okay.

4 BY MR CARLISLE:

5 Q Did you speak with Mr. Chase afterwards?

6 A Yes, yes, I did.

7 Q And can you describe that discussion to us?

8 A Yes. Patty took me up to him, and I went right up
9 to him and said, okay, you wanted me to talk afterwards. What
10 do you make, Bob Chase? Is the Wall Street Journal correct?

11 Q And he responded?

12 A I don't know what I make. I'll send it to you. And
13 then it continued. Do you want me to continue?

14 Q Well, did --

15 MS. FEINBERG: Well, could we have what was said,
16 since I think that was the question, so if there's more of
17 what was said --

18 BY MR. CARLISLE:

19 Q Did he say anything else?

20 A So then he said I'll send it to you, and I said
21 well, don't you know what you make? I mean I thought it was
22 strange. And he said I don't know what I make. Do you know
23 what you make? I said yes, I know what I make. And then he
24 said I'll send it to you. And I said why can't you just look
25 in my eyes and just tell me what you make. I mean we pay your
26 salary.

27 He gave me his business card, and he said for me to
28 give -- actually he didn't give me his business card. He said
